Article 17

Content of Interreg programmes

Set out a joint strategy:

✓ Define joint challenges and regional needs



- ✓ Select your priorities
- ✓ Draft the financing plan
- ✓ List the programme authorities

Phase 1: Input for the programming exercise

- O
- Preparation of the Territorial analysis defining of joint challenges and needs
- Legal framework thematic concentration
- Joint paper and annexes
- Existing national/regional/macro-regional and sea-basin strategies, association agreements and other strategic frameworks (for the partner countries)
- Consultation of socioeconomic partners, regional and local stakeholders and civil society
- Budget of the programme



Phase 2: **Decisions about the strategic orientation** (based on the input from Phase 1)

- Decision on the intervention logic:
 - Policy objectives,
 - Specific Objectives, Priorities,
 - Cooperation actions (types of operations SPF) and
 - indicators
- Decision about operations (projects) of strategic importance, LIPs



Phase 3: Setting the implementation modalities

Decide:

- Management and control structures, liabilities
- Forms of support simplified costs options etc.



Main principles for programming:

Consult – Concentrate - Coordinate



- 1. CONSULT and INVOLVE socio-economic partners, regional and local stakeholders and civil society in the design, delivery and monitoring of programmes
- 2. CONCENTRATE the funds into a limited number of POs, SOs and priorities to have IMPACT
- 3. CO-ORDINATE with other territorial cooperation programmes, macro-regional strategies and EU instruments, including EU assistance to the partner countries



Territorial Analysis

IMPORTANT: Elaborate a fully fledged territorial analysis supported by data on regional level to make good quality strategic decisions!

The range of POs covered – options (partners to agree):

- a) Pre-filtered POs/SOs based on the Joint paper, BUT also respecting the latest thematic concentration agreement
- b) Full range of POs/SOs





Involvement of partners

IMPORTANT: multi-level cooperation should take place at national, regional and local levels throughout all stages of the programming cycle.

Who?

Regional and local bodies, civil society, environmental partners, bodies promoting social inclusion - rights of persons with disabilities - fundamental rights - gender equality and non-discrimination...

How?

Information on programming publicly available at all stages of programming, partners invited to ask questions, to comment draft documents, to participate in person at programming meetings...



Thematic concentration

At least 60% of the EU funds to be allocated on PO2 ("greener") and a max. of 2 other POs

Max. 10 % may be allocated on the Interreg-specific objective of 'a better cooperation governance'

Max. 5 % may be allocated on the external Interregspecific objective of 'a safer and more secure Europe'.

For transnational programmes ("strand B"), if covered by macroregional or sea-basin strategy:

At least 80 % of EU funds (other than TA) to contribute to the objectives of that strategy





Operations of strategic importance & LIPs

IMPORTANT: Pipeline of LIPs to be prepared early!

- Operations of strategic importance: show-case of the programme (Article 17.4(e)(i))
- LIPs can be operations of strategic importance (no obligation)
- Indicative list of LIPs and concept note for each LIP to be submitted for information to the Commission according to Article 55 and 58



Setting the implementation modalities

- Interreg programme authorities (Article 44 ETC)
- Functions of Managing Authority (Article 45 ETC)
- Role of Joint Secretariat (Article 45(2) ETC)

"staff taking into account the programme partnership"

For Interreg programmes also supported by external financing instruments from the Union, one or more branch offices of the Joint Secretariat may be set up in one or more partner countries

 Role of National Authority and National Audit Authority (an independent body) in the partner countries (Article 52 ETC)
